The module has four safe digital outputs for two-channel assignment or eight safe digital outputs for single-channel assignment. Depending on the installation and parameterization, in the SafetyBridge technology V3 system the safety module can achieve the following safety integrity:

- Up to SIL 3 according to standard EN 61508
- Up to SILCL 3 according to standard EN 62061
- Up to Cat. 4/PL e according to standard EN ISO 13849-1


